Online e-quotations are hereby invited by The Director, Directorate of Economic Offences, Government of West Bengal, 5, Council House Street, Kolkata – 700 001 from reputed resourceful bonafide Agencies having sufficient experience in similar nature of works for carrying out the jobs as detailed below:

**1. Name of Work:** SITC of Network Security Firewall & Internet Leased Line Connection for office of the Directorate of Economic Offences, Government of West Bengal, 5, Council House Street, Kolkata – 700 001 for 01(One) year w.e.f. 11.01.2024.

**2. Scope of work:** 50 Mbps (1:1) Internet Leased Line annually with Network Security Firewall. Location: Directorate of Economic Offences, Government of West Bengal, 5, Council House Street, Kolkata – 700 001.

**3. Eligibility:** (i) Experience in similar nature of works within last three years. The intending Quotationer has to produce credential of Rs.1,20,000/- in single work-order. Satisfactory completion certificate from the tender inviting authority or payment certificate will be counted as valid document. The intending bidder must have registered office / service center in Kolkata and address of such office are to be mentioned as Non-Statutory Document along with phone number and official e-mail id.

**(ii) Upto date clearance and submit copy of**

- a) Valid 15 Digit Goods and Services Tax Payer Identification Number (GSTIN) under GST Act.2017;
- b) ITR return acknowledgement of last 3 years;
- c) P. Tax Certificate & latest deposit receipt challan;
- d) Trade License;
- e) Profit and Loss account and Balance Sheet of last 03 years;
- f) Company's Memorandum/ Partnership Deed;
- g) Power of Attorney in case of Company/ Partnership firm etc;
- h) Deed copy in case of Partnership firm;
- i) Valid PAN issued by the IT Department, Govt. of India.

- j) **Form 2911 is to be deposited by the lowest Bidder at the time of formal agreement.**
- k) Affidavit, reference format for general affidavit shown in “Annexure – I” (A declaration in this respect through affidavit has to be furnished by the prospective bidders without which the Technical Bid shall be treated non responsive.)

“Tax Invoice(s) needs to be issued by the Service provider/ supplier for raising claim the contract showing separately the Tax Charged in accordance with the Provisions of GST Act, 2017”

**The eligibility of a bidder will be ascertained on the basis of the self-attested documents insupport of the minimum criteria as mentioned above and the declaration executed through prescribed affidavit in non-judicial stamp paper of appropriate value duly notarized.**

**4. Application to Qualify for procurement of quotation Documents:** Intending agency is required to apply in company’s letter head furnishing firm evidence towards the requirement, stated in sl. No.3 in absence of which, application is liable to rejection.


